## PURPOSE AND SCOPE OF THE POSITION

Responsible for the direct supervision and leading animal technicians on a day-to-day basis, providing husbandry and care for laboratory animals, ensuring high standards of animal welfare and facility hygiene are maintained at all times in accordance with Standard Operating Procedures.

This position will involve assisting the Bioresources Management in ensuring all equipment, staff, and operational procedures are in place to ensure welfare and research needs are met at all times.

The position will work closely with other Bioresources staff on a day-to-day basis. The role will also interact with users of the facility.

### KEY RESPONSIBILITIES

The specific duties include:

- o Oversee the day-to-day work of animal technicians
- o Organise and implement checks and cage change rosters and schedules
- o Undertake and supervise regular animal room and procedure room checks including support areas
- Responsible for ensuring appropriate records are managed, monitored and maintained
- Undertake all animal related duties and responsibilities to the highest of ethical and animal care standards and in compliance with legislation and SOPs
- o Conduct inductions for new staff
- o Provide on-the-job training and mentoring of staff in facility processes and SOPs
- o Assist in coordination of facility works and repairs as required
- o Supervise casual staff and/or work placement students
- o Provide technical support and assistance to staff and facility users in a variety of techniques as required
- o Prepare SOPs for required practices in the facility, including risk assessment when required
- Perform a range of administrative functions including the use and maintenance support of the animal database system, chemical inventory and procurement activities including invoicing and goods receipting
- o Provide regular reports to Bioresources Management as required.
- Support quality assurance activities by contributing to audits, spot check, coordination of QA programs and other activities as required

- Contribute to the successful completion of research projects undertaken within Bioresources by participating in animal experiments and adhering to research protocols and associated standard operating procedures
- Actively communicate with and support research group staff members in a positive and helpful manner in order to maintain the welfare and ethical monitoring standards of animal

- Participate in special projects to continuously improve processes, tools, systems and organisation.
- Take reasonable care to protect own health, safety and welfare at work and avoid affecting the health and safety of any other person at work.
- Participate in the implementation of the Institute's Work, Health and Safety Management System and related laws, regulations and guidelines.
- Ensure that duties are performed in keeping with the principles outlined in SAHMRI's Vision, Mission and Values and the Code of Conduct Policy.
